Delegations and Appointments

<u>6:35 p.m. - Corby Kirwin, C.Tech., SPH Engineering Inc. - Concept drawings</u> of proposed Municipal Office, Child Care and Library building in Mt. Elgin

Corby Kirwin, on behalf of SPH Engineering Inc., presented concept drawings for a new municipal office in Mount Elgin, along with an estimated construction cost of approximately \$450 per square foot.

Discussion took place regarding access to the proposed building for the municipal office, library and council chamber and daycare – Mr. Kirwin explained how the access is separated at the north and south sides of the building. Further discussion took place regarding the opportunity to relocate the janitor's closet on the third floor.

In response to a question from Councillor Ypma regarding if there is a way to adjust the exterior elevations and colours to reflect the previous building's heritage, Mr. Kirwin noted that this would be discussed during the design stage.

It was noted that the building allocates sufficient outdoor play space for the child care facility, as set out and regulated by the provincial *Child Care and Early Years Act, 2014*. The outdoor space is proposed to be located on the south east and south west sides – this would include landscaped play areas

for sun and shade. Consideration will be given to shifting the location of the building on-site to allow for an expansion of the outdoor playground space.

Mayor Mayberry noted that the Oxford County Library Board is considering this proposed library location as a regional hub. Discussion followed regarding the space required, and the ability to utilize the Council Chamber space on the third floor as an activity room. Fixtures such as AV requirements in the floors and walls will need to be taken into consideration during the design stage – there are options to design this as a dual-purpose room for library use.

Council provided direction to staff to bring this forward at an upcoming meeting for further review, including site plan.

Staff Reports

CAO 10-2025: Ingersoll Rotary Club Funding Request from South-West Oxford Township

CAO Mary Ellen Greb provided Council with a report to seek their input regarding a potential grant to the Ingersoll Rotary Club, to assist the Club with some of the capital updates required to re-purpose the former CAMI gymnasium building for food and clothing storage for various community organizations. She noted that Council did not provide funds in the 2025 for this expense. If Council decides to proceed, there are surplus funds coming forward from Council from 2023. This will grow several of the reserves – several of them may be used to off set this expense.

Mayor Mayberry advised that the Rotary Club has not yet finalized their operating budget, they will forward it to the Township once complete.

The purpose of this report is to present Council with a by-law exemption request received from Stephanie Rodrigues, located at 584904 Beachville Road, to permit the keeping of chickens within a residential zone.

AND FURTHER THAT Council approve the by-law exemption request received from Stephanie Rodrigues to permit the keeping of chickens on her property located at 584904 Beachville Road subject to the following conditions:

- A maximum of six (6) hens shall be permitted; roosters shall not be permitted.
- One (1) chicken coop and associated run shall be permitted.
- The total footprint of the chicken coop and run shall not exceed 10 square metres (108 square feet).
- The height of any chicken coop or enclosure shall not exceed 3 metres (9.84 feet).
- Chicken coops or enclosures shall not be permitted in the front yard or interior side yard of a property, as defined in the Township's Zoning By-law.
- Chicken coops and runs must be located a minimum of: o 3 metres (10 feet) from any property line; and o 22.86 metres (75 feet) from any residential dwelling on an adjacent property.
 - Coops and runs must be constructed of materials with openings no greater than 19 mm (³/₄ inch), must include a roof to prevent escape and mingling with wild fowl, and must be secured against predators.
 - Chickens must be kept for personal use only; the sale of eggs, manure, or additional chickens shall not be permitted.
 - The coop and run must be maintained in a clean, sanitary condition, with all waste properly composted or disposed of in accordance with municipal waste guidelines.
 - The keeping of chickens must not result in a nuisance due to noise, odour, unsanitary conditions, or the attraction of pests.
 - Owners shall be advised that should any complaints be received by enforcement staff regarding noise, odour, waste disposal, or chickens wandering off the property, the Township may issue an order requiring the

removal of the chickens and the revocation of the exemption.

<u>7:25 p.m. - Kelly Elliott, Marketing and Communications Specialist -</u> <u>Association of Ontario Road Supervisors (AORS) 2025 AORS Municipal</u> <u>Public Works Trade Show</u>

Kelly Elliott, on behalf of AORS, provided information regarding the upcoming Municipal Public Works Trade Show, which will take place from Wednesday, June 4 to Thursday, June 5, 2025, from 8:00 a.m. to 4:00 p.m. at the Woodstock Fairgrounds. This large-scale trade show is being held in partnership with Oxford County. With over 300 exhibits, the event is expected to draw more than 2,000 attendees over the two days. While it primarily focuses on municipal public works, the show will also feature suppliers from related sectors such as agriculture and drainage. Proceeds from the event will remain in Oxford County and will be donated to local hospitals and food banks.

<u>7:35 p.m. - Consideration of the Engineer's Report - Koteles Municipal Drain</u> <u>DD 06-2025: Koteles Drain Consideration of Engineer's Report</u>

Drainage Superintendent Daniel Leduc presented a report for Council's consideration of the Engineer's Report for the Koteles Municipal Drain, as authorized under Section 76 of the *Drainage Act*. Thomas Jackson of K. Smart Associates Ltd. presented the Engineer's Report.

In response to an inquiry from Councillor Ypma, it was confirmed that the portion of the drain located east of Cranberry Line will retain its status under the *Drainage Act*; only the road crossing is proposed to be abandoned.

The drain will continue to be maintained by the Drainage Superintendent, and properties assessed for the work will be responsible for the associated costs. The drain serves to maintain an outlet through the railway, and the property east of Cranberry Line will continue to have a legal outlet under the *Drainage Act* via the Oxford County right-of-way. Should the property east of Cranberry Line be developed in the future, the drain can be realigned as necessary. A right-of-way through the railway must be maintained. The outlet, as outlined in

the report, could be abandoned in the future if needed; no future agreement is required for its continued use at this time.
